Health

If your child takes medication please notify our staff (send a note) of the details. The Youth Summer Enrichment Camp staff has the authority to refuse any child that may show signs of any contagious illness. In such cases, the judgment of the staff is final and refusal to come pick up the child will result in dismissal from the program.

If your child had a fever, they must be fever free for 24 hours in order to return to the program. Staff also has the authority to request that you provide a note from your child's doctor stating that the child is able to safely return to the program.

Code of Conduct

Participants are expected to exhibit appropriate behavior at all times.

Participants shall:

1. Show respect to participants/staff, and take directions from staff.
2. Refrain from using abusive or foul language.
3. Refrain from causing bodily harm to self, participants or staff.
4. Show respect to equipment, supplies, and facilities.

Participants who do not conform to these rules risk extended time outs, removal from class into the office, suspension, or dismissal from the program.

Disciplinary Action

The Youth Summer Enrichment program will follow a progressive form of discipline as outlined below, if deemed appropriate:

Written or Verbal Warning: Staff will discuss with the parent/guardian the undesirable conduct and why the action is not appropriate. If the action continues, a meeting will be held with the parent to try and resolve the situation prior to suspension.

Suspension: Staff may temporarily ban a participant from a number of activities, games, practices, facility or programs. (The length of the suspension will be determined by the severity of the action).

Dismissal: If inappropriate behavior persists or the behavior completely disrupts a program, removal from the program, facility or activity may be necessary. Once again, the Park District.

Refunds will not be given.

Bus Rules & Regulations For Safety

To ensure safe and orderly means of transportation, the following guiding principles are established for riders:

- Be at the proper location prior to the arrival of the bus.
- Wait on the sidewalk, away from the curb, until the bus comes to a complete stop.
- Go directly to an available seat and be seated in order to keep aisles and exits clear.
- Keep noise at classroom level.
- Keep head, hands, and objects inside the bus.
- Respect the rights and property of others.
- Obey the driver promptly and respectfully.
- If the driver does not see the expected and customary safe environment for any student exiting the bus after school, that student will be asked to re-board the bus. Any student refusal to re-board the bus will require law enforcement involvement.
- Remain seated until the bus has come to a complete stop and use the emergency door only in an emergency.
- No drugs, weapons, hazardous materials, or animals allowed on the bus.
- No objects permitted on bus that cannot be held in a student's lap.
- No profanity, chewing gum, eating or drinking on the bus.
- No throwing or passing objects allowed on, from, or into the bus.
- The bus radio may be played at the driver's discretion. Student requests will be considered to encourage proper behavior on the bus. Please call the director if you have concerns.

Consequences:

1. A Bus Disciplinary Report will be completed by the bus driver as a warning and forwarded to the director.
2. Two (2) Bus Disciplinary Reports will result in a three- to five-day suspension from the privilege of riding the bus.
3. Three (3) Bus Disciplinary Reports will result in an additional ten (10) days suspension from the privilege of riding the bus.
4. Four (4) Bus Disciplinary Reports or zero tolerance offenses will result in suspension from the privilege of riding the bus for the remainder of the program.
5. The parent/legal guardian is held legally responsible for any damage to the bus and/or bus equipment by his/her child.

*The Nelson Resource Center's Bus is a courtesy extension of the program; therefore, students should conduct themselves in a consistent manner with established safety standards and classroom conduct. Students are still under the direct supervision of the staff and bus driver while riding.

*When necessary, this document may be modified per the Board's discretion.
